Instructions & Guidelines (Rules & Regulations)

All the selected participants will agree and abide by rules and codes of conduct prior to and throughout their 7-day visit. Some rules are designed for safety; others are to help students/ youth integrate into the new place and culture. There is a standard list of exposure program rules in the application, which must be read and signed by the student and his or her parents/ guardian and shall be submitted with other documents and registration form.

1. The participants shall not be allowed to possess or use illegal drugs. However, restricted medicine shall be allowed upon a presenting prescription by a physician.
2. The participants shall not be authorized to operate a motorized vehicle of any kind which requires a federal/ state license or to participate in driver education programs.
3. Stealing and fraud shall be prohibited. There shall be no exceptions.
4. Unauthorized traveling shall not be allowed. Individual and/ or unsupervised travel shall not be allowed. Participants must always follow the travel rules of the management team.
5. The participants must abide by the rules and conditions of the place of visit including; Corporate Industries/ Universities/ Legislative Assemblies/ Government Institutions, Religious Places of the Host City.
6. Any other expense other than the exposure program due to a participant's activity shall be the responsibility of the participant and his/ her parents and or guardians.
7. Leaving the premises of venue or accommodation during the visit time and stay shall be strictly discouraged and participants shall not be allowed doing so. Additionally it will be mandatory for all the participants and accompanying staff to wear/ display chest cards during the exposure program for ease of security personnel and or management team for recognition and avoiding any conflict etc.
8. Use of indecent language, derogatory remarks (whether direct or implied) about important personalities, national leaders, political parties, national institutions, government agencies, various religions & their beliefs and or law enforcement agencies, religions, religious places/ institutions, sects etc. during the event shall lead to disqualification and respective participant shall be sent back.
9. All participants shall be expected to act graciously during their stay and interact with other participants, officials, guests and management team respectfully. Failure to do so shall result in disqualification.
10. Participants are also expected to behave well and take care of their luggage along with the properties present at event venue and their respective accommodation place. In case of any participant found damaging any property at accommodation place, venue place or any other thing related to project, shall be fined and will be immediate returned to home.
11. Bringing any material related to political, religious or sectarian violence/ thoughts/ organizations to venue or accommodation places is strictly prohibited. Any participant found with any such material or promulgating any sect, religion or political party shall be disqualified and shall be directed to leave the venue. Hooting in the venue and political, sectarian or religious slogans shall be strongly discouraged and any participant found doing so shall be disqualified

- 12.** Participants must bring their CNICs/ Form-B and Student ID Cards otherwise they will not be allowed to participate
- 13.** Participants shall not be allowed to bring any sort of weapons (arms) or ammunition
- 14.** Management Team shall be authorized to share the participants data (pictures, videos, testimonials, ideas, information and other documents etc) for the promotion and good name of the Department/ Government of Khyber Pakhtunkhwa and its Stakeholders on relevant/ appropriate mediums.
- 15.** Participants shall specifically take care of all the norms and values of other religions, their ideologies, their places and their followers alongwith their respective believes in all manners at all places.
- 16.** Registering for participation in the exposure program would means that the respective individual accepts all the rules and regulations

I, hereby declare that, I will neither join in any coercive agitation/ strike for the purpose of forcing the authorities of the exchange program to solve any problem, nor I will participate in any activity which has a tendency to disturb the peace, tranquility and schedule of the trip of the exchange program and/ or its accommodation premises.
8. I, hereby declare that, neither I will indulge in any form of activity, even in words or intentions that might hamper the activities of the exchange program.
9. I will not be permitted to possess or use any motorized vehicle during the trip, possess
